Meritorious team commendation award given flotilla members

Eighteen members of Coast Guard Auxiliary 12-3, headquartered at Flotilla Island on Lake Murray, were recipients of the Coast Guard Meritorious Tem Commendation award during the quarterlt Division Meeting and Change of Watch of Division 12 of the Seventh District, last Saturday.

The commendations, signed by Rear Admiral T. W. Allen, US Coast Guard Commander, Seventh Coast Guard District, were presented by Commander Alan Marsilio, executive officer for Marine Safety at Group Charleston.

Also during the meeting, Joe Richbourg, who currently is commander of Flotilla 12-3, received the Coast Guard Auxiliary Award of Merit, signed by Commander Peter DiNicola, USCG, COmmanding Officer Group Charleston.

Jay Dahlgren, Rear Commodore-North D7 and a memeber of Flotilla 12-3, who presented the special award to Richbourg, said the Award of Merit is awarded by the Coast Guard to members of the Auxiliary in recognition of sustrained professional and/or leadership achievements, which in the case of Richbourg's honor, was in operations.

The Coast Guard Meritorious Team Commendation was given to the 18 members who participated in the spill of

more than 1,000 gallons of highly flammable gasoline at Lighthouse Marina on Lake Murray in September of last year.

Rear Admiral Allen said in the citation that "Upon learning of the spill at the marinathrough your vigilant monitoring of distress radio frequiencies, you immediately dispatched available Auxiliary resources to the scene to support the South Carolina Department og natural Resources, the County Sheriff and the private contractor's cleanup effort.

The citation recognized that "within one hour, 18 Auxiliary members, five Auxiliary operational facilities and one Auxilary personal watercraft were in position near the entrance channel leading to the marina, helping to keep boaters out of danger and ensuing response personnel had the best conditions for conducting the cleanup."

As a result, the citation notes that "...you diverted hundreds of boaters from harm's way and thereby kept external ignition

sources from causing a mahor catastrophe due to the volatile ambient atmosphere. Your substantial efforts also saved more thatn 500 private craft moored at the marina. Your selfless involvement throughout this two-day ordeal permitted the safe and effective removal of the spolled gasoline and prevented further environmental and personal harm to all users of Lake Murray.

The citation said the "dedication, pride and professionalism displayed by Coast Guard Auxiliary Lake Murray Foltilla reflects credit upon each team member, the United States Coast Guard Auxiliary and the United States Coast Guard."

During the presentation of the special citation to Commander Richbourg, Dahlgren observed that in the four divisions he oversees, this is the only time the award has been made. To earn the special honor, he said that Richbourg provided outstanding operations support and leadershipt for Flotilla 12-3 during a busy summer patrol last year. He said that Richbourg was personally involved in 23 assists and aided 59 persons, two of whom were recovered from the water.

He said that the commanding officer of the Charleston Coast Guard Station recently cited Richbourg for his superb planning and successgul prosecution of a night search and rescue resulting in the rescue of four children.

"Mr. Richbourg has played a key role in formattion the efforts of the Auxiliary to work with all elements of the SC State in carrying out the safety of the lake Murray area," said Dahlgren. "The relationships and perosnal courtesy shared by this group is unprecendented in 53 years Flotilla 12-3 has patrolled Lake Murray, Mr Richbourg's outstanding administrative achievements as a flotilla staff offiver have also resulted in

an increase in Flotilla membershipt of 28 percent. His diligence, perseverance and call to duty are to be highly commended, They reflect the highest tradition of the US Coast Guard.

A special guest at the meeting was Lt. Mike Williams, head of hunter and boaring safety for the South Carolina Department of Natural Resources. He told the Coast Guard Auxiliary that "in the field of boating safety education, you definately have been an asset to our department, especially since the new boating law became effective last year. We appreciate what you've done in helping us with towing and assisting boaters in need. You've been a great help and we cna't tell you how much we appreiate it."

The quarterly meeting was hosted by the Lake Murray Coast Guard Auziliary at the South Carolina Forestry Service on Broad River Road, Columbia, last Saturday morning. Following the business meeting, change of watch ceremony and presentation of awards, members were treated to a barbeque meal served by Hawg Haven of Prosperity.
